Chlorine Dioxide in Solution (CDS)

DISCLAIMER: I share my notes in good faith but provide links to sources in case I have misinterpreted them. You need to check my sources and interpretations of them for yourself.

BACKGROUND

COVID-19 is said to be a new virus. Whereas the 1918 flu killed through respiratory and multi-organ failure, COVID-19 seems to cause silent hypoxia (shortage of oxygen in the blood) and blood clotting impeding circulation leading to multi-organ failure.

Initially, the medical regulators banned the use of outpatient treatments, which physicians claimed were preventing hospitalisation and saving lives. Instead, patients were only treated when they were already very sick and unable to breathe, requiring intensive care in hospitals. Many patients died because of COVID-19 or within 28 days of catching it. I know of elderly people who were only sent palliative treatment for use at home if needed and we stopped our GP placing a DNA-CPR order on my husband. This led to me submitting <u>evidence to the Parliamentary Inquiry into the Human Rights Implications of the Coronavirus Act</u>.

Adherence to WHO recommendations led to countries waiting for development and supply of vaccines, which did not become available until late 2020 and were still in short supply at the time of writing these notes (Apr 2021). There were many fatalities in the interim which continued even after the rollout of vaccination into February 2021.

Concerned physicians re-purposed treatments approved for other purposes in their frantic attempts to save lives. They found that the off-patent antimalarial drugs (Ivermectin and Hydroxychloroquine) when used in combination with other supplements were effective in preventing infection and saving already infected patients. The physicians were optimistic since these drugs had been well studied over decades of practice. But, they were barred from using these treatments by medical regulators, like the US National Institutes of Health (NIH) and the US Food and Drugs Administration (FDA). They even prohibited proper clinical trials of these safe drugs for COVID-19. They changed their recommendation regarding clinical trials for Ivermectin after testimonies by leading experts to a Senate Hearing and a heated campaign by the American Front Line Doctors. It seems unbelievable that government regulators opted to let people die while waiting for vaccines and ignored the pleas of medical professionals who were begging to let them save lives with available treatments. The mainstream media had a field day in the meantime ridiculing President Trump for suggesting Hydroxychloroquine.

They also ridiculed his suggestion that his team should look into the disinfectant Chlorine Dioxide (ClO_2) which the FDA disingenuously referred to it as bleach (NaClO). ClO_2 was already being used to treat malaria. The FDA warned against it saying that it was dangerous. In fact, a 1981 report on a double blind clinical trial undertaken under the auspices of the US Environmental Protection Agency (EPA) had found no adverse physiological effect on humans at even 24 mg/litre, which is much higher than the maximum for potable water of o.8 mg/l. When Bolivia legalised the use of ClO_2 against COVID, there was a dramatic fall in deaths. This led to the formation of COMUSAV consisting of over 3000 doctors and other professionals in about 20 countries. The doctors are not allowed to use ClO_2 in hospitals, nursing homes and so on in countries other than Bolivia. Even so with

COMUSAV doctors treating patients in their own homes, there was a reduction in deaths as evident on the WHO COVID-19 dashboard.

There are on-going controversies over prophylactics and anti-viral treatments. The treatments may not work for everyone since we are all constitutionally different. The same is true of vaccines. They do not work on everyone either. Also, in March 2021 several countries suspended the use of some vaccines after serious side effects and deaths following vaccination although no causal links were established.

COMUSAV has acquired a great deal of experience in using ClO₂ in solution (CDS) as reported in its online English conference. There are claims that those who took bicarbonate of soda during the 1918 pandemic did not catch the flu and those who were already infected were cured by it. CDS is a more potent oxygenator of blood than bicarbonate of soda, which has many therapeutic uses which we have personal experience of. This was the reason for:

- My writing to the UK Select Committee on Health and Social Care to state that The UK should investigate the claim that Chlorine Dioxide in Solution (CDS) offers prophylactic and early treatment for viral infections, such as Covid-19
- My e-petition to Parliament to gain support from others

I feel that governments have a duty to explore all treatments to save lives, livelihoods and the economy given that public health measures have disrupted all walks of life. Given the testimony of those who are saving the lives of those infected with COVID-19, vaccines should be seen as just another prophylactic and not the only solution to a global threat, especially when vaccines are in short supply and their long term effects are still unknown.
